產品描述:

聚酯基材雙面膠帶 8005, 係以聚酯薄膜為基材, 對於膠帶裁切加工之尺寸穩定性佳, 並於貼合及沖切加工具有優異之操作性. 其壓克力膠系結合高黏著力與優異之剪切力, 保持力之特性, 適合各種表面之貼合, 包括多種塑膠件.

聚酯基材雙面膠帶 8005, 係適用於電子產品之系統組立, 平面顯示器產業之需求設計, 諸如銘板, 光學薄膜之黏貼, 泡棉, 絕緣膜之貼著固定.

產品特徵

- 3M 8005 係膠性軟硬適中之感壓膠系統, 其主要之特性表現結合高黏著強度與高保持力, 剪切力特性, 且可貼合於各種表面, 包含多種塑膠表面

膠帶使用操作程序

貼合表現與有效貼合面積息息相關，堅實之感壓程序可明顯增加膠帶之貼合表現。以下系 3M 建議之標準膠帶使用操作程序：

- (a) 欲達最佳黏著，黏著表面必需清潔與乾燥。一般建議以布沾取1：1 比例之IPA (Isopropyl Alcohol, 異丙醇) 與水的混合溶液進行表面擦拭清潔後，待表面完全乾燥。(注意：使用IPA前，請先參照此溶劑之建議注意事項)。
- (b) 在清潔溶劑乾燥後，將膠帶貼合於黏著表面，以滾筒或其他方式(刮板) 平均施以約 15psi (1.05公斤/cm²) 之壓力，使其有效貼合。
- (c) 將膠帶離型紙撕除，然後將欲貼著之材質貼上，同樣施以15psi 之壓力，使其有效貼合，若欲去除氣泡，建議加大壓力，以物品所承受之限度為上限。
- (d) 建議理想的施工溫度介於15°C 至38°C 之間，勿低於10°C。
- (e) 欲使膠帶保存至使用時仍具有穩定的品質，建議之儲存環境為21°C和50%相對濕度。
- (f) 黏貼膠帶時，宜以一端先貼合後，再緩壓至另一端，以減低氣泡產生之機率。
